## Memorandum of Understanding (MOU)

This Memorandum of Understanding ("MOU") is entered into on 11th Oct 2024, by and between Government College Drang at Narla Himachal Pradesh represented by [Dr. Kalyan Chand Mandhotra], hereinafter referred to as "Government College Drang at Narla," Prajapita Brahma Kumaris Ishwariya Vishwa Vidyalaya ("PBKIVV"), represented by [Rajayogini BK Anjana], hereinafter referred to as "PBKIVV."

1. Purpose: The purpose of this MOU is to establish a collaboration between Government College Drang at Narla and PBKIVV to enhance the quality of education and holistic development of students.

2. Scope of Collaboration: PBKIVV agrees to provide services to Government College Drang at Narla in the following areas:

- Stress Management: Conduct workshops, seminars, and training sessions on stress management techniques tailored for students and faculty members.

- De-addiction Programs: Organize awareness programs and counselling sessions to address addiction-related issues among students.

- Values in Life: Offer lectures, discussions, and interactive sessions focusing on ethical values, moral education, and character-building.

- Meditation: Integrate meditation practices into the college curriculum and offer guidance on mindfulness and spiritual well-being.

3. Duration: This MOU shall be effective from the date of signing and shall remain in force for a period of 5 years unless terminated earlier by mutual agreement.

#### 4. Responsibilities of Government College Drang at Narla:

- Provide necessary infrastructure and facilities for conducting the agreed-upon programs.

- Promote and encourage students and faculty to actively participate in the activities organized by PBKIVV.

#### 5. Responsibilities of PBKIVV:

Design and deliver high-quality programs on stress management, de-addiction, values in life, and meditation.

- Provide qualified trainers, materials, and resources required for the successful implementation of the programs.

6. Intellectual Property Rights: Any intellectual property developed or utilized during the collaboration shall be jointly owned by Government College Drang at Narla and PBKIVV.
7. **Confidentiality:** Both parties agree to maintain the confidentiality of any sensitive information shared during the collaboration.
8. **Termination:** Either party may terminate this MOU with three months advance written notice to the other party.
9. **Amendment:** Any amendment to this MOU must be made in writing and signed by authorized representatives of both parties.
10. **Governing Law:** This MOU shall be governed by and construed in accordance with the laws of Himachal Pradesh jurisdiction.
